## **AFTER SCHOOL PROGRAMMING CONTINUES AT BALDWIN!!!**

The Baldwin Middle School will be starting an after school program/ homework club beginning February 4<sup>th</sup>. The program will occur on Mondays and Wednesdays until mid- May. Snacks and transportation home will be provided. The program will last until 4:30pm.

### **Monday Program: Homework Club**

This is available to all students who are in need of completing homework assignments and is not intended to be a social time or a babysitting service. The sessions will take place in the library with teachers present and access to computers will be available.

### **Wednesday Program: Activities**

This is available to all students who are interested in being active at school and programs such as art, physical fitness, community service, and homework club may be offered. Specific programs will be based on student interest and staff availability.

The sessions will be from 3:30PM until 4:30PM with snacks included AND a late bus will be provided to those students participating. Parents will be able to pick up their child from the program OR use the late bus for transportation. It is imperative that parents communicate participation and transportation needs with the school so that proper planning can be performed. ## **Baldwin Middle School After School Homework Club Permission to Participate**
