On conference call with Nexogy- 8 phones will be shipped within 10 days. We are looking at receiving 85 phones from them; All issues will be resolved and then on a specific date we will port the phone numbers. We will be able to call out on the new phones as soon as they are hooked up but we will not be able to receive phone calls on the new phone until the port happens. Lois asked who will be the point person on this account? Lois and Janice need to sign into the online account for billing. Lois will set it up. Tom M. will work with Ryan D. on the tech side of the contract and signing into that part of the phone system. When that is complete, the phones will be shipped to us Next step would be a site survey- So Paul, Tom and Ryan D. will do a walk through of both building to be sure all the CAT 5 drops are in place for all 85 phones. Ryan DelMastro is concerned that the current internet at CES will not handle the load of this VOIP system however, we are in the process of setting up fiber optics connection between CES and BMS within the next 6 to 8 months. There are some nice features on these phones such as we will be able to make and review work phone calls on our cell phones if necessary, we can also receive voice mail via our email.
